While AAHS facilities are located in Athens-Clarke County, GA, the organization serves those in need throughout the state, and rehuses in Clarke, Jackson, Oconee, Oglethorpe, Barrow, and Madison counties. Services include case management, child care assistance, transportation, shelter and rehousing assistance. In 2019, AAHS sheltered and/or housed over 200 children and their families.
