THE ORGANIZATION IS EXEMPT FROM INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE. THE SHELTER PROVIDES TRANSITIONAL HOUSING FOR PEOPLE EXPERIENCING HOMELESSNESS IN ATHENS-CLARKE COUNTY, GEORGIA. WOMEN AND CHILDREN LIVE AT THE FACILITY OWNED BY THE SHELTER, AND RESIDENTS ARE PROVIDED WITH HOLISTIC AND COLLABORATIVE CASE MANAGEMENT. PROGRAMMING AND FINANCIAL ASSISTANCE OFFERED BY THE SHELTER SUPPORTS FAMILIES AS THEY WORK TOWARD PERMANENT HOUSING AND EMPLOYMENT.
